AT RIGGS DISTRIBUTING, INC., WE WANT TO ENCOURAGE HOME BUILDERS TO INCORPORATE THE FULL LINEUP OF THESE APPLIANCES INTO THE HOMES THEY BUILD. ACCORDINGLY, RIGGS DISTRIBUTING, INC. IS OFFERING SUBSTANTIAL REBATES WHEN HOME BUILDERS MEET SPECIFIC THRESHOLDS FOR USING SUB-ZERO, WOLF, AND COVE PRODUCTS IN THEIR PROJECTS.



#### **TERMS AND CONDITONS**

• Eligible Projects & Products: Riggs Distributing, Inc. offers an exclusive rebate to Home Builders who install serialized Sub-Zero, Wolf, Cove and/or Best appliances in new construction homes and remodel projects.

### Rebate Tiers for Serialized Units (Within 12 Months from the First Delivery):

- o **1–7 Serialized Units:** No rebate
- o 8-14 Serialized Units: 5% rebate (applies retroactively to all units delivered once the 8th unit is reached)
- o 15+ Serialized Units: 10% rebate (applies retroactively to all units delivered once the 15th unit is reached)
- **Program Period:** The eligibility window for calculating the rebate is a 12-month period starting from the date of the first qualifying appliance delivery.
- **Purchasing Requirements:** All qualifying appliances must be serialized units purchased from an Authorized Dealer of Riggs Distributing, Inc.
- **Delivery Requirements:** All qualifying appliances must be delivered within the same 12-month period starting from the first delivery date.
- Claim Submission: To receive the rebate, Home Builders must submit a completed and signed 2025 Custom Home Builder Rebate Program Claim Form, along with a copy of the dealer's invoice. The invoice must show the date of sale, date(s) of delivery, and all Sub-Zero, Wolf, Cove and/or Best model and serial numbers. The Claim Form must be submitted within 30 days of reaching a qualifying tier (8 or 15 major serialized units) during the 12-month period.
- Verification & Approval: Incomplete claim forms, or those referencing purchases that cannot be verified by Riggs Distributing, Inc., will be voided. Riggs Distributing, Inc. reserves the right to audit all claims and, if necessary, conduct a physical inspection of the installed products before issuing any rebates.
- Rebate Payment: Upon verification, Riggs Distributing, Inc. will mail the rebate check directly to the Home Builder. Rebates are paid once the builder meets a qualifying threshold and include a catch-up payment for all previously delivered units in that 12-month period. Please allow six (6) to eight (8) weeks from the date of claim submission to receive the rebate check.



### 2025 CUSTOM HOME BUILDER REBATE PROGRAM

#### Process for Dealers:

### 1. Home Builder Registration:

Complete the Custom Home Builder Rebate Registration Form for any new builder that has not been previously registered.

#### 2. Unique Identifier Assignment:

Upon receiving the registration form, the Sales Operations team will assign a unique identifier to that builder, which must be referenced in all future orders.

#### 3. Order Placement Procedure:

When placing an order on behalf of the registered builder:

- o Add "QTExxxx" to the builder's unique identifier at the beginning of the PO number.
- o Include the builder's unique identifier in the comment section of the sales order management system.

#### Claim Submission by Builder:

Once the qualifying threshold is met, complete the Custom Home Builder Rebate Program Claim Form and email it to: <u>riggssalesops@riggsdistributing.com</u> to receive the rebate.
